- 1) Being over 18 years of age, I hereby make application for exhibition space in the Smith Street Fun Day Sunday Festival to be held on the above date, accepting my assigned space as final.
- 2) I understand that it is the law of the City of New York that all vendors have to be properly licensed or authorized by the Department of Consumer Affairs, and that sale of alcoholic beverages including beer and wine is only permitted by vendors who obtain the proper permit. I acknowledge my responsibility to pay sales tax on all sales directly to government authorities myself.
- 3) I will conduct myself in a civil manner and will refrain from the use of intoxicants at the Festival; will be properly attired; will avoid any misconduct which would bring discredit to the Festival; and will not violate the Police regulations under which permission to hold the event is granted.

**NO AMPLIFIED MUSIC PERMITTED WITHOUT PRIOR NOTICE AND APPROVAL**

- 4) Parking must be legal. There is **NO PARKING on SMITH STREET**.
- 5) I agree to exhibit no work constituting propaganda of any kind. I will not offend the moral or religious sensibilities of any group. I will refrain from giving lectures of any kind. My exhibit will involve no gambling and no games of chance.
- 6) I agree to hold harmless and indemnify from any and all liability and claims whatsoever in nature, including reasonable attorney's fees, the South Brooklyn Local Development Corporation & Clearview Productions Inc., their directors, officers, employees, contractors, as well as property owners in front of whose property I am privileged to exhibit.
- 7) I understand and agree that the event is planned for Sunday, 06/23/19 Rain or Shine. There are **NO REFUNDS** in the event of rain. The NYC Street Activity Permit Office has mandated the official time span of every event permitted in NYC to 10am to 6pm.
- 8) I understand that standard space will easily accommodate a 10X10 Tent. Two or more adjacent spaces may be purchased if more space is required. Set-up is in the street, not on the sidewalk, along the curb. Displays must be self-standing.
- 9) I understand that I must bring my own tables, chairs, displays etc. and that the registration fee covers only the empty space that I am assigned.
- 10) I expressly agree that this application and the acceptance of same may be unilaterally terminated at any time, including the day of the Fair, by the SBLDC with or without cause, upon reimbursement of the registration fee to the named exhibitor.
